## 2015-2016 Preschool Programming Options: Waitsfield Elementary School

## **Background information**

There are 30 children (best estimate) living in town who will be eligible for preschool programming in 2015-2016: 11 four year olds (8 currently enrolled in WES 3 year old program); and 19 three year olds (15 have indicated an interest in accessing WES-based program.)

In 2014-2015, the preschool program switched days (3 year old program now runs M/W and 4 year old program T/Th/F) allowing for students to access both a local private preschool (Spring Hill School) and Waitsfield Elementary preschool. There are a few students in our 3 year old program (aprox. 1/3) who attend both schools. For the first time since preschool programming was begun at WES, all of the eligible four year olds are in the WES program, with over half attending both Waitsfield Elementary School and Spring Hill School. Additionally, mid-day bus transportation was added this year, allowing families working full days and/or without personal transportation to access the WES program. Several of our students in both the three and four year old programs ride the bus, many of them traveling to an afternoon childcare provider.

In the past, "aftercare" was provided to preschool students through the non-profit Open Hearth: After School Kids. This program proved to not be financially sustainable and ceased a few years ago after just two years of operation. The preschool day was moved from 11:30 a.m. dismissal to 12:30 p.m. in 2012-2013, incorporating access to our lunch program. Students in the three year old program receive 10 hours of programming per week; those in the four year old program receive 15.

The current preschool license capacity is for 15 children, based upon the square footage of the preschool room. We have traditionally capped the program at 12, holding spaces for 2-3 more children should any child with special education needs move in to our community. We have accessed these additional spaces only once in my six years at Waitsfield Elementary.

The preschool is staffed by one lead teacher and one assistant teacher.

2015-2016 budget draft #1 included \$45,000 for additional preschool expenses. Further investigation revealed there were fewer students than we initially anticipated; depending upon the options selected, additional (new money) costs could range from 21,000 to 8,000.
